

IPEDS DATA FEEDBACK REPORT 2024 HIGHLIGHTS AND PEER INSTITUTIONS DASHBOARDS

The IPEDS Data Feedback Report for Year 2024, released in January 2025 by the National Center for Education Statistics (NCES), offers an insightful comparison of Baylor College of Medicine (BCM) to its peer institutions at the national level. Key findings include:

Enrollment and Diversity

- BCM shows robust enrollment figures. Diversity remains a strength, with balanced enrollment across multiple racial and gender groups.
- Total 12-month enrollment is consistent, with full-time equivalent (FTE) enrollment aligning closely with the median of peer institutions.

Program Offerings

• BCM provides a broad range of programs and remains a leader in academic productivity. The number of degrees conferred in AY 2022-23 places BCM among the top performers in medical and health education.

Distance Education

 While BCM does not have students exclusively enrolled in distance education programs, it exceeds its peers in the proportion of students taking at least one distance education course. This indicates BCM's growing integration of virtual or hybrid learning components, striking a balance between traditional in-person learning and flexible, technology-driven education.

Core Revenues

• BCM stands out with 55% of its core revenue derived from private gifts, grants, and contracts - significantly higher than the peer median of 16%. This reflects a strong foundation of external support and funding.


